- Note 1:** This fee only applies to examinations offered by AINDT, some examinations are only available from AQB's, refer to guide for details.
- Note 2:** Not required if level 2 practical has been done in the method applied for within the last 10 years; refer to guide section for details.
- Note 3:** Once the application forms have been received no changes to personnel, venue or examination date will be accepted without additional administration fees being charged.
- Note 4:** Applications can be given priority processing once all required documentation (including all applicable exam results) has been received by the Federal Office. The turnaround time for this certificate will be effected within 5 working days.

- *Member:** Membership must be continuous since issue of certification on order for member discount rates to be applied to renewals/re-certification
- To be eligible for discounts on AINDT certification fees, candidates/certificate holders are required to be current financial members of the AINDT when applying for certification.
 - To be eligible for discounts on AINDT Renewal and/or Re-Certification fees, candidates/certificate holders are required to have held continuous AINDT membership for the previous 5 years without interruption.

****Non-Member:** Means a natural person, corporate or incorporated association admitted to associate membership, Student membership or is an un-financial member of the AINDT.
